Club Pure Reward Programme Terms and Conditions

1. The Purelife Reward Card Programme (“Programme”) is operated by Purelife Solutions Limited (“Purelife”). The Programme is open to UK residents aged 18 or over. A Programme member shall be referred to as “Member” in these terms and conditions.
2. Members will receive points on qualifying purchases which is currently calculated at the rate of 5 points for every £1 spent. The number of points issued may vary between qualifying purchases. Reward points can be used as part payment towards a transaction.
3. Members can redeem points against purchases at Purelife at a value of £1.00 per 100 points. The lowest number of points that can be redeemed at any one time is 500 and above that, Members can only redeem points in multiples of 100.
4. Purelife reserves the right not to award points in respect of products or treatments that are on sale or discounted in any way.
5. If a transaction on which points are earned or redeemed is cancelled or reversed or a product is returned (in accordance with Purelife’s returns policy), Purelife will reverse the associated points earned or redeemed. If a transaction is exchanged for one of a lower points value, Purelife shall be entitled to cancel the balance of points between those originally collected and those collected in respect of the replacement transaction.
6. Purelife reserves the right to withdraw any rewards from the Programme, at any time, including for legal or regulatory reasons.
7. In addition to regular mailings, points balances will usually be advised to Members on till receipts from transactions qualifying for points.
8. Points will be added at the time of purchase and cannot be added at a later date without the prior approval of the Manager.
9. To redeem points the Member must ask the staff at the till at the beginning of the transaction.
10. Points will only be awarded for transactions that are being paid for by cash, cheque, debit or credit card. If points are redeemed in part payment of a transaction, points will only be awarded on the cash balance of that transaction.
11. The points have no cash redemption value and cannot be exchanged, sold or transferred to another Member. No change or credit will be given for any overpayment using points.
12. It is the responsibility of the card member to notify Purelife if their contact details are incorrect or change.
13. If a Member has not earned points for a period of six consecutive months, all previous points earned will automatically expire.
14. Purelife reserves the right to amend these terms and conditions or suspend or terminate the Programme at any time. If the Programme is terminated (for whatever reason) the Member’s rights to earn or redeem points are lost. Purelife will give the member as much notice as it reasonably can.
15. These terms and conditions are subject to English Law.
16. These terms and conditions do not affect your statutory rights.
